What is this product?

Type

Unit Linked. This product is not offered on a stand-alone basis, but is only offered with the insurance product.

Term

The recommended holding period is 20 years.

Objectives

The Growth Fund aims to achieve long-term unit growth by investing in both foreign and local equities and equity Funds. Fixed income investments are considered to be of secondary importance and are likely to be minimal. The investment policy is based on achieving both capital gains and income from returns on portfolio investments. At the same time, investment risk is reduced because of investment diversification and the long-term horizon.

Intended retail investor

This product is suitable for investors who are willing to take a high investment risk and expect a high return with a long-term investment horizon.

What are the risks and what could I get in return?



The risk indicator assumes you keep the product for 20 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less. Information regarding the surrender charges can be found in section “How long should I hold it and can I take money out early?”

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because the Manufacturer is not able to pay you. We have classified this product as 4 out of 7, which is a **medium** risk class. This classification takes into consideration two elements: the market risk that rates the potential losses from future performance at a **medium** level, and the credit risk, which estimates that poor market conditions are **very unlikely** to impact the capacity of the Manufacturer to pay you. This product does not include any protection from future market performance so you could lose some or all of your investment.

The unfavourable, moderate, and favourable scenarios shown are illustrations using the worst, average, and best performance of the product over the last 25 years.
